Subject: CALAFCO Annual Conference and Business Meeting

The Commission will receive a report on the annual CALAFCO conference to be held in October. The Commission may also consider voting in the Board Member election to

be held during the annual business meeting at the conference

BACKGROUND

California Association of Local Agency Formation Commission (CALAFCO) sponsors a three-day annual conference towards the end of the calendar year. The program is typically theme-based with sessions generally geared towards commissioners and executive staff. Typically, about 300 LAFCo commissioners and staff attend.

DISCUSSION

The CALAFCO 2024 Annual Conference is scheduled for October 16-18th at the Tenaya Lodge near Yosemite. A conference announcement is included as Attachment A. The Commission has not budgeted for registration or lodging costs and as such, there will be no voting delegate in attendance for the business meeting that will be held at the conference which will include Board Member elections. Staff has requested an absentee ballot which is scheduled to be sent out after October 1st.

While there is currently limited budget for conferences and staff workshops due to the annual CalPERS payment for former Executive Officer retirement benefits, attendance at these events can be beneficial to the Commission. They allow for networking with Commissioners throughout the state and can provide a wealth of information of the efficient development of agencies and the provision of local services. Staff would encourage the Commission to consider budgeting for attendance at future conferences. Additionally, staff would be interested in hosting either the annual CALAFCO staff workshop or conference once the CalPERS payments are finished.

RECOMMENDATION

Staff recommends the Commission take action to vote for CALAFCO Board Members, or designate an individual to vote on behalf on the Commission once the ballot is received, and provide direction to staff on future attendance at annual conferences.
